### Contest Rules, Regulations and Contestant Entry Form

**Saturday July 8, 2016 @ 2:30pm Victoria Fields, Whitby, Ontario**

- 10 local Rib Eating Contestants will be selected to participate in **Whitby Ribfest's** 6<sup>th</sup> Annual Rib Eating Contest by representatives from **Whitby Ribfest & Halenda's Meats**.
- Contest open to any Canadian resident, 18 years of age and older. Members, volunteers, employees, representatives and agents of the Rotary Club of Whitby Sunrise, **Whitby Ribfest** and **Halenda's Meats** are not eligible to participate.
- An Entry fee of \$30 per contestant is due and payable to the Rotary Club of Whitby Sunrise within 5 days of being selected to participate.
- The weight of ribs will be measured before & after the Contest. The winner of the Contest will be the participant with the highest weight differential between the weight of the ribs before the contest and the weight of the ribs after the Contest.
- Each participant will have 10 minutes to consume as many ribs as possible
- A judge will be assigned to each contestant to ensure all rules are followed.
- 1<sup>st</sup> place Trophy & Prize package with total value of \$500 will be awarded to the Winner.
- Prize package will be provided to the 2<sup>nd</sup> place contestant containing \$200 of frozen food from **Halenda's Meats**.
- The prizes must be accepted as awarded, and no substitution or transfer of prizes is permitted, provided that **Whitby Ribfest** reserves the right to substitute a prize of equal or greater value in the event that the said prizes are unavailable.
